RE: Land Resources Subcommittee - Surface Water Quality BMP Cost-share Applications

The district has received 26 Cost-Share Assistance Applications for FY'22 NRD funds, totaling \$370,536. All applications are for installing conservation measures on cropland, and will qualify for the Summer Conservation Program with an added 15% in cost-sharing (totaling 75% average cost and 85% actual cost, whichever is less) and a \$17,500 cap. Three of the applications are located in a targeted area having an 85% cost-sharing rate and a \$22,500 cap.
