LAND MANAGEMENT MAINTENANCE TECHNICIAN

DESCRIPTION: Under the general supervision of the Land & Flood Control Operations Coordinator, the employee will carry-out the operations and maintenance required of District equipment, facilities, and properties.

EXAMPLES OF DUTIES/RESPONSIBILITIES: (A position may not be assigned all the duties listed, nor do the listed examples include all the duties that may be assigned).

Performs needed maintenance of completed District projects and properties under District responsibility, including flood control dams, urban creek channels, stream stability projects, trails, Salt Creek levees, stormwater BMPs, and wetlands. Assists in the maintenance of public use areas of the District properties.

Operates various District hand and powered equipment in accordance with safety training. Knowledge of tractor and skid loader operation preferred.

Performs necessary maintenance of District equipment.

Provides assistance on maintenance of partner's projects and properties, as directed.

Assists in implementation of District weed control program and performs weed control on District projects through either mechanical and/or chemical application. Obtains necessary training/certification.

Assists in snow removal and grounds and building maintenance at the District headquarters.

KNOWLEDGE OF: Natural resources, land management, maintenance, construction, repair and operation methods of vehicles, pulling trailers, heavy equipment, facilities, and property of the District.

ABILITY TO: Prioritize and complete required duties in a timely manner with limited supervision and understand instructions. Acquire state certification for the application of pesticides. Proficiency in Microsoft Office Suite.

SKILL IN: Construction, carpentry, mechanical techniques and methods, pesticide application, operation of equipment and natural resource management.

Must have a valid Driver's License.

Physical: Must be able to lift 25-50 pounds from ground level to chest. Able to work outdoors in all types of conditions.
