This dry dam along Ash Hollow Creek, south of Waverly, will be completed in the spring. The NRD and the City of Waverly are each funding half of the nearly \$3 million project cost. It will control flooding in the town and remove about 90 properties from the floodplain. Flood insurance would no longer be necessary in order to get loans to buy those properties. The dry dam will only hold water after a storm, releasing it at a controlled rate.

Seedling Sales in Bloom

Ordering of about 30 species of seedling trees and shrubs from the NRD continues until March 24th. Landowners can order online, by mail (print an order form online) or by visiting the NRD office at 3125 Portia Street, Lincoln. Trees will be delivered to the NRD in early April and stored in our custom tree cooler until you're ready to plant them in April or We recommend planting Mav. the seedlings immediately after you pick them up from the NRD office. Most of the seedlings are between 24 inches and 36 inches in length, including the roots,

Stevens Leads Board

Deadman's Run Study Update

A preliminary plan has surfaced to reduce the risk of flooding in a portion of Lincoln's Deadman's Run Watershed. After two years of study, the U.S. Army Corps of Engineers (Corps) has determined several flood reduction measures it may be able to help fund in an area from Salt Creek, upstream to just past 48th Street. The NRD and the City of Lincoln are the local sponsors of the study.

The Preliminary Preferred Alternative that emerged from the Corps study was introduced at a public open house on January

and 100 or more can usually be packed in a single box that is easy to handle and can fit into any vehicle. In the past, the NRD has offered to plant seedlings for cooperators. Unfortunately, the outside help we utilized is no longer available; however we have produced a new tree seedling planting video. Search "lower platte south nrd" on YouTube.

Seedlings cost \$0.85 per plant for 75 or fewer and \$0.80 per plant for 100 or more and each species must be ordered in increments of 25. Acreage packages of 50 seedlings (five species/ten seedlings each) specially selected for specific uses are also available. The NRD is non-profit and operates the program with a goal of breaking even. Lower Platte South's annual sales have averaged around 30,000 seedlings per year since the program began in its current form about 15 years ago and the 23 NRDs throughout Nebraska sell nearly one million seedlings per year. Summer Conservation

Each fall, the demand for NRD cost-sharing to construct terraces, waterways and other land improvements exceeds the number of available contractors and some projects are not able to be constructed. In response, the NRD Board has increased the time window to May 1 - Sept. 15 and increased cost-sharing to 15% in its Summer Conservation Program. The board hopes the changes encourage more landowners to install best management practices during the summer months, when more contractors are available. Contact your NRCS office or the NRD for details.

Interested citizens study Deadman's Run floodplain maps at an open house held January 17th at Nebraska Educational Telecommunications.

- 17th. More than 100 people attended to learn more about the plan. The preliminary plan includes:
- widening and improving the Deadman's Run Channel from 48th Street to Cornhusker Highway
- replacing bridges at 33rd and 48th streets
- creating a detention basin just west of the Fleming Fields sports complex
- relocating an access road east of State Fair Park Drive
- and improving the channel under the railroad tracks, west of 33rd Street, to convey water more quickly

Corps Planner and Project Manager Jeff Bohlken told the crowd the Corps study yielded four alternatives, but the Preliminary Preferred Alternative is the only one of the four in which the benefits of construction would exceed the cost; a prerequisite to the Corps being able to provide funding. The estimated cost of the plan is \$20 million and the benefit-to-cost ratio is 1.5 to 1.0. Bohlken said if the plan is approved, the Corps could provide up to \$10 million, with the balance of the cost coming from local sources.

Flood insurance would no longer be required in order to receive loans to buy properties removed from the floodplain. More study is needed this winter to determine exactly what properties would be removed. Bohlken also introduced a tentative timeline for the project, with the final design completed in September 2018, landrights negotiations done by spring 2018, construction starting in the summer or fall of 2019 and completion in spring 2021. FEMA floodplain maps would then be re-drawn, officially removing properties, possibly by fall 2022.

All eight of our public-use lakes are open this winter. There are no entry

Nothing is more important than safety when ice fishing. Four inches of clear, newly formed ice is safe to walk on, but a foot of old ice that has partially thawed may not be safe. Stay aware. Rule Changes

Changes to two sets of NRD rules and regulations took effect in January. Public hearings were held in late 2016 on changes to ground water rules and to the NRD's Erosion and Sediment Control Program and the changes were approved by the NRD Board before they took effect. The ground water rule changes relate to:

- prohibiting irrigated acre increases in the Dwight-Valparaiso-Brainard Special Management Area
- water well permit requirements
- decertifying irrigated acres
- extending irrigation allocations for three more years in part of the Dwight-Valparaiso-Brainard Special Management Area
- and more

Changes to the Erosion and Sediment Control Program mostly parallel recent definition and terminology changes statewide. Complete Ground Water Rules and Regulations and pertinent sections of the Erosion and Sediment Control Program are available at lpsnrd.org or contact the NRD.

Conservation Legislation

Each year, the NRD identifies bills introduced in the Legislature that may modify the many ways we preserve and protect natural resources. Below are some of the bills and resolutions we are watching this session:

LR 4 - explores the need for a more comprehensive statewide water quality study

LBs 22,23 & 24 - budget measures to compensate for the more than \$267 million state budget shortfall

LB 98 - gives NRDs that have fully or over-appropriated water supplies increased taxing authority for certain groundwater management activities.

LB 182 - makes more rural water systems eligible for low interest loans

LB 232 - proposes property leased to the state, NRD or other government subdivision be exempt from property taxes

LB 71 - increases the amount appropriated for the Nebraska Tree Recovery Program, as the emerald ash borer invades Nebraska

Salt Creek Trail, 14th to Cornhusker at 23rd Street - Planning phase. Expected completion in 2017.

Marsh Wren Saline Wetland Restoration - East of 48th along Salt Creek. Completion in 2017. Yost Construction \$629,596

Ash Hollow Dry Dam, Waverly - Completion expected this spring (see page1). Construction cost, \$1.2 million: 50% City of Waverly, 50% NRD. Commercial Contractors

Havlat Road Structure - dam completed near 168th and Pioneers, south of Pleasant Dale. B-D Construction \$368,308

Salt Creek Levee-Rosa Parks Trail - Landrights and permitting phase. 80% NE Dept. of Roads, 20% NRD. Expected completion in 2017.
