

Seventeen cost-share applications for assistance have been received for installing water quality improvement practices. They are for the NRD's Fall Conservation Program. The Land Resources Subcommittee did not meet, however, the applications were reviewed by the Eastern and Western Review Groups. All applications fit the criteria for the Fall Conservation Cost-Share Program. Three applications are located in a targeted area, two of those are located in the new 319 Twin Lakes Watershed area. Staff recommends approval of the seventeen Fall Conservation Program Cost-Share Applications in an amount totaling \$201,803.


